WGC 2020 Full Golf Membership Incentive:

Must join before December 31th 2020 and after the course closes.

The rate for the "New Full Golf Member" remains at \$2,500 flat per year *(not inclusive of taxes, handicap fees, club storage fees, range fees, locker fees or minimums).*

Must be paid in two payments 1/2 when approved for membership and 1/2 by July 31st. then 1/2 by January 31st and July 31st in the following year on the program.

Dues \$1550 Assessment \$950 The dues are taxable. One half is due at approval.
One half of the total: \$1,327.50 (Dues \$775 plus tax = \$852.50 Plus Assessment \$475)

Refundable stock purchase of \$510 required at approval.

Available to those who have not been a WGC full golfing member after December 31st 2018.

Tenure during this period for the New Member can only be accrued if the New Member remains a Full golfing member after the program rate is complete.

Details: Current rates subject to change.

This program is for the calendar years 2021, and 2022.

Range fee is \$75 plus tax.

Handicap fee is \$30

Food and beverage minimum is \$1000 per year, \$750 for age 22-34, in 3 trimester periods of \$333.33, or \$250 each for members.

Optional bag storage and locker are \$100 each.

Members are responsible for any future assessments implemented by the Board of Governors.

When adding a spouse from the dues schedule;

Spouse additional restaurant minimum is \$200/ year

A refundable investment of \$102.00 WGC stock is required at time of commitment.
